BS 28/07/2011**: "the supply and construction of asphalt surface, base correction, milling and replace with BTB, slurry seal, crack sealing" and chip and spray: 3 Year term Contract" As and when required" with the name of the Tenderer, shall be deposited in the tender box provided at the Steve Tshwete Local Municipality on the 2<sup>nd</sup> floor, Civic Centre, Wanderers Avenue, Middelburg, before **12:00** on the closing date. The tenders will be opened in public.

The closing date for receipt of tenders is **12 September 2011 at 12h00**. Telegraphic, Telephonic, Telex, Facsimile, e-mail and late tenders will not be accepted. Contractors who have the following are eligible to tender and must provide such proof:

- Original Valid Tax Clearance Certificate
- Company Registration Certificate
- CIDB Certificate.

Bids will be pre-qualified in accordance with functionality criteria as outlined in the tender. Only the bids that meet the minimum number of points out of the total number of points for functionality will proceed to the price and preference goals evaluation stage.

*A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with the Preferential Procurement Policy Framework Act, Act No 5 of 2000 and as defined in the Conditions of Tender in the tender document, read in conjunction with the Supply Chain Management Policy of Steve Tshwete Local Municipality where 90 points will be allocated in respect of price and 10 points in respect of targeted goals. Tenderers must have the necessary skills, experience and capacity to perform the required work.*

No awards will be made to a person:

- Who is in the service of the state,
- If that person is not a natural person, of which any director, manager, principal shareholder or stakeholder is a person in the service of the state
