A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with the Preferential Procurement Policy Framework Act, Act No 5 of 2000 and as defined in the Conditions of Tender in the tender document, read in conjunction with the Supply Chain Management Policy of Steve Tshwete Local Municipality where 80/90 points will be allocated in respect of price and 20/10 points in respect of targeted goals. Tenderers must have the necessary skills, experience and capacity to perform the required work.

No awards will be made to a person:

- If that person is not a natural person , of which any director, manager, principal shareholder or stakeholder is a person in the service of the state
- Who is an advisor or consultant contracted with the municipality or municipal entity
